# Company's Activities

- Innovation River is involved in two European research projects:
  - **MATISSE** is a European **HORIZON KDT-JU** research project focused on model-based engineering of Digital Twins for early verification and validation of industrial systems. The project involves **30 partners from 7 countries**, where Innovation River acts as **Italian Country Coordinator and Technology Provider in cryptographic**.
  - **PROACTIF** is a European **HORIZON JU-Chips 2024-1-IA** research initiative entitled "*Unmanned Vehicles for Civil Security and Surveillance Missions*". The project brings together **42 partners from 13 countries**, with Innovation River contributing as **Technology Provider in cryptographic communication protocols**.
- What sort of interaction exists with one of the 3IAs or other ETPs?
  - Regular interaction through participation in **technical workshops, conferences, and networking events**, as well as **active contributions to Strategic Research Agendas (SRAs) and technology roadmaps**, supporting alignment with European research and innovation priorities.
